Resident Profile: Tamara Nowicki.... <u>Her Story</u>

"The True Lives of Brunette the Horse and Goldie the Chicken"

Tamara wrote this wonderful story about her early years in the Ukraine. She grew up in a loving home with her father, mother and younger brother. In her book she tells of the unique relationship she had with her horse *Brunette*, a gift from her father, and her chicken *Goldie*.

Tamara was born in the Ukraine in 1922. She went to University to study Dentistry, but when WWII broke out, Germany occupied the Ukraine and all the universities in the Ukraine were closed. The young people were sent by force to Germany to work. She lived there with a family for five

years, working in a dental office and also looking after a small boy.

During the war, many people were being sent to Siberia. Tamara was afraid that she would be sent there too; so she decided to migrate to

the United States. She applied at the American Embassy but was not successful because the quota was filled. She then applied to the Canadian Embassy to come to Canada. Her application was accepted and in 1951 Tamara arrived in Halifax, Nova Scotia. She moved from Halifax to Toronto and took a job at The Hospital for Sick Children sterilizing instruments.

FROM SANDY'S DESK



I want to inform you of an upcoming **planned power outage** here at The Wexford. This will take place in either late May or June and will last for **approximately 4-6 hours**. We need to replace our hydro transformer and switchgear as it is almost 35 years old and past

its useful life. This is a major project and we are working with Toronto Hydro, specialized electrical and mechanical engineers and consultants to plan this work. The current hydro transformer and switchgear are located in an underground hydro vault located beneath the concrete section of the driveway, by Gooderham Drive. There had been 3 pylons placed in this area over the winter and you probably noticed that they took up two parking spaces.

There are **two main phases** to this project: Phase 1) The installation of the new hydro transformer and switchgear onto the grassy boulevard just outside the main dining room along Gooderham Drive.

Phase 2) Decommissioning the current hydro vault.

All Phase 1 work will be completed prior to the cutover of power to the building. This is when power to the building will be cut off; however, the emergency generator will be on at this time. We are planning to turn off the power after lunch and expect it to be back on four hours later but we are planning for six hours. Residents will have a cold dinner plate, having had their hot dinner at lunch time. We will be bringing on extra staff to ensure that all the residents are well cared for during this time.

We are also working with the Tenant Association Executive to plan for their needs. We are hoping that many of the tenants will go on a bus trip to Casino Rama that day, so that they will not be inconvenienced at all by the power outage.

Phase 2 begins once Phase 1 is complete and normal power is in place. The Gooderham entrance will be closed for about one month while they decommission the vault. There will be reduced parking at that time and I ask for your patience as this work must be done.

We will be submitting a plan to the MOHLTC covering all aspects of resident care. They are aware of the planning that is currently going on and will review and approve our plans prior to beginning the work.

Other Updates:

I am pleased to announce that the 3rd floor dining room will be open by the end of March. This was a very complex project and took much longer than any of us anticipated. The residents already love the bright, open space and are excited for the new location. The staff love the fact that it is so convenient to the unit and residents are encouraged to walk to the dining room, as part of their walking program; this is truly a win-win situation for everyone. Thanks to **Medical Pharmacies** for their financial support of this project!

AODA: Accessibility for Ontarians with Disability Act, 2005

Effective January 1, 2012 the first standard of this new Act: **Customer Service**, became law.

The Standard: Making customer service accessible for people with disabilities.

All staff and volunteers require training on this customer service standard. The training includes:

- 1. Purpose of the act
- 2. Requirements of the customer service standard
- 1. Serving customers with disabilities
- 2. Service animals
- 3. Support persons
- 4. Assistive devices
- 5. If there are difficulties accessing your Services

The other components of the Act will be phased in and are to be complete by 2025. These include:

- 1. Transportation
- 2. Information and Communication
- 3. Employment
- 4. Built environment

FAMILY PETS VISITING RESIDENT POLICY

The Wexford Residence recognizes that pet visitation can enhance a residents' quality

of life. However, appropriate precautions must be taken to ensure optimal health of the residents and the animals.

According to the Long-Term Care Homes Act, family members, friends or staff wanting to bring their animals (eg: cat,dog) to visit with a resident must comply with the following:

- All pets must have up-to-date immunizations and their immunization records, from a qualified veterinarian, must be given to the Director of Life Enrichment, Wayne Connelly, on an annual basis.
- It is the responsibility of each visitor to care for their pet and ensure their animals are not disruptive, malicious or destructive.
- Reception will have a binder with an updated list of pets who are able to visit and you will be asked to sign in your pet when you visit.
